



SACC ARIZONA PRIVACY POLICY WITH GDPR AND MODEL RELEASE

SACC Arizona, the Swedish-American Chamber of Commerce Arizona, is part of the SACC-USA network of Swedish-American Chambers of Commerce. SACC Arizona operates as an independent corporation under its own by-laws, with a mission in line with the larger network, following operating procedures outlined by SACC-USA. This privacy policy will explain how SACC Arizona uses the personal data we collect from you when you use our website, sign up for newsletters, events, or join as a member.

What data do we collect?

SACC Arizona collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Data shared by you as you fill out registration forms on the website.
- E-mail content when you communicate with us through e-mail.
- Data relating to your interaction with our communications, website, and events, including photos and audio / video recordings arising from the same.

YOU HEREBY GRANT SACC ARIZONA THE IRREVOCABLE AND UNRESTRICTED RIGHT TO USE AND PUBLISH PHOTOGRAPHS, AUDIO RECORDINGS, AND VIDEO RECORDINGS OF YOU, OR IN WHICH YOU MAY BE INCLUDED, FOR EDITORIAL TRADE, ADVERTISING AND ANY OTHER PURPOSE AND IN ANY MANNER AND MEDIUM, AND TO ALTER THE SAME WITHOUT RESTRICTION, AND RELEASE SACC ARIZONA FROM ALL CLAIMS AND LIABILITY RELATING TO THE PHOTOGRAPHS, AUDIO RECORDINGS, AND VIDEO RECORDINGS. HOWEVER, IF YOU ARE COVERED BY THE GENERAL DATA PROTECTION REGULATION, YOU MAY EXERCISE YOUR RIGHT TO WITHDRAW THE USE OF YOUR PHOTOGRAPHS, AUDIO RECORDINGS, AND VIDEO RECORDINGS ANYTIME FROM THE EFFECTIVITY OF THIS CONSENT, AFTER WHICH, YOU ARE GIVEN THE RIGHT TO ASK TO CEASE THE USE OF YOUR PHOTOGRAPHS, AUDIO RECORDINGS, AND VIDEO RECORDINGS THEREAFTER BY CONTACTING US AS PROVIDED HEREIN.

How do we collect your data?

You directly provide SACC Arizona with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website, emails, or newsletters, via your browser's cookies.
- SACC Arizona may also receive your data indirectly from SACC USA and our partners.

How will we use your data?

SACC Arizona collects your data so we can:

- Email you regarding news and events we think you might like.
- Process your requests and manage your account.
- Send you reminders and reach out in person.

If you agree, SACC Arizona will share your data, not including phone number, with our member companies and event sponsors so they may offer you their products and services.

When SACC Arizona processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases, and to the processor of payments. We use various payment processing providers including, but not limited to, PayPal, and Affinipay.

How do we store your data?

SACC Arizona securely stores your data at the secure servers of our internet providers. These providers include, but may not be limited to, GoDaddy, for email services, and Wild Apricot owned by Personify, for content hosting and member data management, and Mail Chimp, for newsletters.

SACC Arizona will keep your personal information for up to 8 years after your last interaction. Once this time has passed, we will delete your data by removing archived contact data.

Marketing

SACC Arizona would like to send you information about our activities and events, and about organizations that you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop SACC Arizona from contacting you for marketing purposes or giving your data to other members of SACC Arizona.

If you no longer wish to be contacted for marketing purposes, we are happy to help you adjust your preference settings. Let us know by email, or, if you are a member, please visit our website and log in to your account. As a subscriber to our newsletters, you make adjustments following the link in the newsletter received.

What are your data protection rights?

SACC Arizona would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request SACC Arizona for copies of your personal data. We may charge you a small fee for this service to cover expenses incurred.

The right to rectification - You have the right to request that SACC Arizona correct any information you believe is inaccurate. You also have the right to request SACC Arizona to complete information you believe is incomplete.

The right to erasure - You have the right to request that SACC Arizona erase your personal data.

The right to restrict processing - You have the right to request that SACC Arizona restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to SACC Arizona's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that SACC Arizona transfer the data we have collected to another organization, or directly to you, under certain conditions.

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

How do we use cookies?

SACC Arizona uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website

What types of cookies do we use?

There are a number of different types of cookies; however, our website uses:

Functionality - SACC Arizona uses these cookies so we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and your location. A mix of first-party and third-party cookies are used.

Advertising - SACC Arizona uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. SACC Arizona sometimes shares limited aspects of this data with third parties for advertising purposes. We may also share onlinedata collected through cookies with our advertising partners. This means when you visit another website, you may be shown advertising based on your browsing patterns on our website.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.

Privacy policies of other websites

The SACC Arizona website contains links to other websites. Our privacy policy applies only to our website, so if you click on a link to another website, you should read their privacy policy.
